Similarly, most debt incurred during the marriage is "marital debt." "Nonmarital property" is property that you acquired before the marriage, inherited before or during the marriage and certain gifts that you receive during the marriage. "Nonmarital debt" is debt incurred before the marriage.</p> <p>Typically:</p> <ul style="list-style-type: none"> • Marital property is divided evenly between you and your spouse • Marital debt is divided between you and your spouse, sometimes evenly and sometimes based upon you income compared to your spouse's income • Nonmarital property is given to its owner
